

**Decision no. 19, dated 24.02.2026**

**(V-19/26)**

Constitutional Court of the Republic of Albania composed of: Fiona Papajorgji, President, Marsida Xhaferllari, Sonila Bejtja, Ilir Toska, Genti Ibrahim, Marjana Semini, Sandër Beci, members, with court secretary Anjeza Puka, on 26.11.2025 and 24.02.2026 took under examination in plenary session on the basis of submitted documents, the case no. 5 (Sh) 2025 of the Basic Court Register, pertaining to:

**APPLICANT:** “GECI” LLC. COMPANY, represented with power of attorney, by lawyers Besim Hajdarmataj and Eritan Shehu.

**INTERESTED ENTITY:** **MINISTRY OF INFRASTRUCTURE AND ENERGY,**  
in absentia.

**SUBJECT MATTER:** **Repeal of Decision no. 00-2024-4330 (460), dated 31.10.2024 of the Administrative College of the High Court, as incompatible with the Constitution of the Republic of Albania.**  
**Remanding of the case to the Administrative College of the High Court for further proceedings.**

**LEGAL BASIS:** **Articles 42, 131, point 1, letter “f” and 141 of the Constitution of the Republic of Albania (*the Constitution*); Articles 27 et seq. of Law No. 8577, dated 10 February 2000 “On the organization and functioning of the Constitutional Court of the Republic of Albania”, (*Court’s Organic Law*), as amended.**

Constitutional Court, pursuant to Articles 131, point 1, letter “f” and 134, points 1, letter “i” and 2, of the Constitution, as well as Articles 72, 73, point 4, et seq. of Law No. 8577, dated 10 February 2000 “On the organization and functioning of the Constitutional Court of the Republic of Albania”, as amended,

**DECIDED:**

1. Rejection of the application.
